

Event Waiver

In consideration of the services of CKA/Get:Outdoors (hereafter "CKA"), their agents, owners, sponsors, volunteers, participants and all other persons or entities acting on their behalf (hereinafter referred to collectively as CKA), I hereby agree to release CKA on behalf of myself, my children, my parents, my heirs, assigns, personal representatives, and estate as follows:

1. I acknowledge that canoeing, kayaking and kayak fishing entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property or third parties. I acknowledge that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.

The risks include, among other things: Whitewater rapids; your boat could turn over and/or you could have to swim rapids risking collision with rocks or entanglement with trees or debris; head injuries, you could slip or fall during a hike, resulting in damage to equipment or personal injury; exposure to natural elements can be uncomfortable and/or harmful; you should be aware that this exposure could result in sunburn, dehydration, heat exhaustion, heat stroke; also prolonged exposure to cold water can result in hypothermia; exposure to potentially dangerous wildlife, insects and plants; and accidental drowning is also a possibility. Furthermore, CKA directors might be unaware of a participant's fitness or abilities. They might misjudge the elements, the weather or the terrain. They may give inadequate warnings or instructions.

2. I expressly agree and promise to assume all of the risks existing in this activity. My participation in this activity is purely voluntary and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge and agree to indemnify and hold harmless CKA from any and all claims or causes of action which are in any way connected with my participation in this activity or my use of CKA equipment or facilities, including any such claims which allege negligent acts or omissions of CKA.
4. Should CKA, or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold CKA harmless for all such fees and costs.
5. I certify that I have adequate insurance to cover any such injury and/or damage that I may cause or suffer while participating, or else I agree to bear all costs for such injury and/or damage myself. I further certify that I have no medical or physical conditions, which could interfere with my safety in this activity, or else I am willing to assume and bear the costs of all risks that may be created, directly or indirectly, by any such condition.
6. In the event that I file a lawsuit against CKA, I agree to do so solely in the state of North Carolina, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules in that state. I agree that if any portion of this agreement is to be found void and unenforceable, the remaining portions shall remain in full force and effect.
7. By participating in this event, I agree to accept all the decisions made by tournament

Directors regarding competition results and will not request a refund or contest any and all competition results.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against, CKA on the basis of any claim from which I have released them herein.

I have had sufficient opportunity to read this entire document. I have read and understood this document, and agree to be bound by its terms.
